## The YouthHope's Foundation's Insurance Requirements:

- A. The vendor/contractor shall secure the minimum insurance coverage described below, and such insurance shall be primary with respect to any insurance or self-insurance programs maintained by the City.
- *Worker's Compensation and Employer's Liability* insurance in the amount that meets the statutory requirement shall be in force with an insurance carrier acceptable to the City.
  - *Comprehensive Commercial General Liability* insurance in the amount of one million dollars (\$1,000,000.00) per occurrence and two million dollars (\$2,000,000.00) aggregate shall be in force with an insurance carrier acceptable to the City and name YouthHope and the City as additional insured. {Three million dollars (\$3,000,000.00) aggregate for projects with greater exposure.}
  - *Commercial Automobile Liability* insurance with minimum limits of one million dollars (\$1,000,000.00) per occurrence combined single limit for bodily injury liability and property damage liability shall be in force with an insurance carrier acceptable to the City and name YouthHope and the City as additional insured. This coverage shall include all owned vehicles, hired and non-owned vehicles, and employee non-ownership vehicles.
- B. The vendor/contractor shall instruct their insurance agent/broker to furnish properly executed certificates of insurance to the City. Certificates of insurance shall clearly show evidence of the coverage required above.
